1. **CALL TO ORDER:** The meeting was called to order at 7:35 a.m.
2. **APPROVE THE AGENDA:** The agenda was approved
3. **INTRODUCTIONS:** None
4. **APPROVE MINUTES:** Minutes of the June 22, 2021 and August 24, 2021 meetings were approved.
5. **DISCUSSION ITEMS:**

- a. Future of the Economic Development Committee. The Committee members discussed their role and the future of the Committee. Overall, members felt that meetings need to return to in-person, and the committee needed a stronger role and involvement in City planning and with the City Council; specifically, when there were code changes or new policies that affected the City's business community. It was also agreed that the Committee needed more diversity, a Chair person, fill the vacancies, and a Committee/citizen suggested agenda.

Councilmember Merrill felt the EDC was essentially invisible to Council. Other committees, boards and commissions provided expected deliverables to Council, and were given tasks and were involved with Council and land use/planning.

- b. Small Business Recovery Program. Ms. Poischbeg updated the Committee on the Small Business Recovery Program offered by Retail Strategies. The program was in the first phase, which focused on encouraging small businesses to take advantage of the expertise being offered by Retail Strategies, who was currently working on analytics and real-time statistics and data. Thirty-five participants attended a workshop and even more will receive a recording of the workshop. Five local businesses have signed up for consulting.

It was suggested that the Experience Snohomish website be updated.

6. **MEMBER UPDATES:** Ms. Poischbeg mentioned the County contacted her about the Midtown District's height restrictions. Mr. Cole stated not all members of the task force agreed on the height recommendation. It was suggested the Planning Director attend an EDC meeting to discuss this matter with the Committee.
7. **STAFF UPDATE:** Ms. Poischbeg reported the City's next Quarterly Magazine had added 8 pages devoted to holiday retail in support of the Retail Strategies project.
8. **REPORTS:**
 - a. Sales Tax Report - Sales tax figures through the end of August show year-to-date total sales tax revenues are up 10.3% from last year.
 - b. Available Properties – Not discussed
 - c. The Commercial Permit Activity report was provided.
 - d. New Business Licenses – A list of new business licenses issued since the last meeting was provided.
 - e. Closed Business Licenses – A list of closed business licenses since last meeting was provided.
