Vibrant Cities Presentation September 25 at Lynnwood Center

If you're interested how you can support making Snohomish a more vibrant and healthy community, you may want to take advantage of a free public event on September 25 sponsored by Community Transit from 6:30 p.m. to 8:00 p.m. at the Lynnwood Convention Center.

The event will feature Gil Penalosa, executive director of the Canadian non-profit 8-80 Cities organization. The 8-80 group is dedicated to developing and encouraging policies that address the needs of all citizens from 8 to 80 years old. His presentation will focus on: how to create vibrant communities that benefit both residents and businesses; the benefits of making public transit,

walking and cycling a normal part of everyday community life; the role of streets—the largest public space of any city—in vibrant communities; and how parks contribute to improving quality of life.

Mr. Penalosa holds an MBA and has consulted more than 150 cities worldwide on how they can create more vibrant and healthy communities. Additional sponsors of the event include the Puget Sound Regional Council and the 8-80 Cities organization.
