**City Council Discussion of
Retail and Medical Marijuana
Postponed to February 16**

The City Council's anticipated discussion of current prohibitions concerning retail recreational and medical marijuana sales, previously set for February 2, has been rescheduled to February 16.

The February 16 discussion is expected to include a review of new laws combining retail sales of medical and recreational marijuana, changes in distribution of state revenues and other aspects of the state's laws affecting how such sales may be permitted within cities.

Under the state's laws cities are permitted to decide individually whether they wish to permit retail marijuana sales as well as permit cultivation and processing operations within their local zoning and land use regulations.

The City Council has up to this point prohibited any retail sales and commercial processing or cultivation within its land use regulations.
