Construct 2 new 3-story buildings

First Building: 4 (3 bedroom, 2.5 bath row houses with 1 car garage. 1654 sq ft ea.)

Second Building: 1 commercial space on main floor with 723 sq ft. The 2nd and 3rd floor will be a single family residence with 3 bed, 2 bath home at 1872 sq ft and a 2 car garage.

Project will have 13 total parking spots, of which 6 will be garaged, and one will be an ADA van accessible.
